Minutes of the Airmyn Parish Council meeting held on Wednesday 12 July 2017 at 7.00pm.

Councillors present S Hayward(Chair), T L Longden, St John Meyers, S Scott and I Williamson. 3 members public 50/1718 Co-option of new councillors. Mrs C Healey was welcomed to the council and signed the Declaration of Office and Localism form. Copies were given of the good Councillors guide 2017, note re Councils acting as sole trustee of a charity and the Good Councillors guide to neighbourhood planning.

51/1718 Apologies for absence. C Fox.

52/1718 Confirmation of minutes. The minutes of the parish council meeting held on 14 June 2017 were signed as a true and complete record.

53/1718 Declarations of interest. None declared.

54/1718 Information on ongoing issues.

54.1 Bracken Hill. A site meeting was held with Leah Hallas from The Conservation volunteers who had carried out the work on the site to date. Her projected plans for the year ahead were discussed. All agreed the stipulation that public access should be available at the end of the project in 2018 was a very real problem with the grant conditions. The parish council have to clarify who will action what in the year ahead, ensure insurance requirements are met and signage and safety concerns are looked at in depth. Both L Hallas and the Two Ridings, who have allocated the grant, of £10460 for the year ahead, agree that the project must move forward with volunteers in the years ahead and not be the parish council responsibility following the conclusion of the grant. The project could be re-visited in the future if residents express interest in the area. Grants could be sourced again in those circumstances. Resolved, following a lengthy discussion, that the grant application will not be signed by the parish council at this time. Much has been achieved to date and many successful community activities have been well supported.

54.2 Traffic plans from ERYC. As expected these are beyond the financial capabilities of this parish council. £41,000 for three chicanes, street lighting, speed cushions, signs and lines. Traffic regulation order, safety audits and £12,900 for lining and signing only with traffic regulation order, safety audits and design with traffic management costs. Resolved: no action to be taken at this time.

54.3 ERYC New traffic plans. A recent newsletter article from a resident clearly established no increased traffic through the village. There will be no ERYC council funding or priorities given to this village as the many years of work by residents have established regarding the speeding concerns. The 20mph speed limits aren't enforceable and until the Elite factory opens then this matter will be taken off the agenda.

54.4 Openreach transmission box. This has been installed in line with planning guidance. No further action can be taken.

54.5 Football Pitch. Currently the grass contractor is carrying out extra cuts free of charge to clear the grass from the pitch. Eastern Raiders have volunteered to roll the pitch and carry out extra cuts as well as line the pitch for the season. Historically it was never thought that the playing field would be rented out but available for community use. Resolved the new season costs to Eastern Raiders will be £17.50 per hour as they no longer require indoor training.

54.6 Grass surrounding the playing field. Actions required. No actions presented for discussion. Removed from the agenda.

54.7 Bowls club. A possible grant application is being considered by the Bowls Club. Meeting held at 4pm on the 12 July with the secretary and Airmyn bowls club member. The lease amount for next year will be kept the same at £105 as the village asset is extremely well looked after. The retaining wall at the compost heap will be looked at by the bowls club. The electric position maybe sorted with the addition of another meter using EDF energy charities area, it is thought they have a social and needs fund. Clerk to access and report back.

55/1718 Planning

17/01930 Dr Gould 61 High Street Airmyn. Application of external wall insulation with render finish (brick effect) to front and side. On the East Riding of Yorkshire Council planning portal there is an heritage report which objects to the plans proposed. Resolved to accept this report and reject the proposed plans.

17/01736 Miss V Haigh Conversion of Barn to dwelling Land East of Boothferry farm Ferry Lane Airmyn. Full planning permission. Resolved no objections. Noted the bat report will have to be considered and applied.

17/01921 Mr M Lowe. Erection of single storey extension to side following demolition of existing. Westfield House 91 High Street Airmyn. Resolved to make no comments or objections to these plans.

56/1718 Issues raised by councillors

56.1 Tarmac issues at the hall. The parish councillors had looked at the area and sought advice from residents involved in the building of the hall and lean-to storeroom. The tarmac problem could be resolved by re-laying more tarmac in that area. The hall work was carried out by Roy-Al builders from Rawcliffe. The foundations for the storeroom did not have the same specifications as at the hall. Clerk asked to obtain quotes for this work.

56.2 Flags. Purchase of new ones. No presentation was made on this item.

56.3 New Cheque signatories St John Meyers and S Scott were appointed as cheque signatories.

56.4 Clarification of protocol for communication within the parish council. A Thompson will be willing to set up any councillors with a parish council email address. Reply to all is a favoured way of communicating by email, with care always being taken when using this method of communication to ensure that emails go to the correct recipients.

57/1718 Issues arising from new correspondence

57.1 ERYC Member Code of Conduct. Resolved to adopt the New Code of Conduct as adopted by ERYC 25 July 2012. Forms completed by the parish councillors had been sent to ERYC.

57.2 Goole & Airmyn Internal Drainage Board. The chair had received a letter from Goole Drainage Board querying the minutes of the parish council meeting held on the 12 April 2017. The three Councillors and the members of the public present at that meeting were aware that Councillor Fox is also a member of the drainage board but an error was made in not recording this in the minutes. No further action to be taken.

57.3 Defibrillator Training. The Emergency Team had felt that another session of training on the use of the defibrillator would be a good idea and had explored the matter with Andrew Percy MP. Mr Percy's office had promised to give £100 donation towards this training, run by Yorkshire Air Ambulance, which costs £200 per session. The team asked the Parish Council to contribute the other £100 so that this could go ahead.

Resolved to make the contribution of £100. Mrs H Cowling is to arrange this event.

58/1718. Upcoming meetings None

59/1718 Ward Councillor's reports. Mrs C Fox had dealt with a drainage problem at 109 High Street on behalf of a resident.

60/1718 Safety Concerns

Urgent items from Taskforce walkabout this morning. 4 parish councillors, the clerk and two ERYC officials walked the whole village and a report will be received in due course. There are no immediate safety actions. Overgrown vegetation is an issue many villages have problems with but it was apparent that the areas of concern in Airmyn would receive attention soon. ERYC can issue a letter to any resident who is preventing residents walking on a footpath or blocking visibility for cyclists. Airmyn residents spend a large amount of time gardening, maintaining trees, hedges and bushes. There were concerns about the Environment agency stone bastions on the riverbank in the area where pigs are rooting on the bank edge. Several other concerns were raised about the riverbank in this area with regard to flood protection issues.

Resolved: The Clerk to contact the Environment agency about these concerns.

The gates for the public right of way on the riverbank. These are the responsibility of ERYC, who erected them and should deal with any signage on them. A complaint had been received that the gates are being left open and the relevant officer will be asked if this matter can be dealt with by installing self-closing mechanisms.

61/1718 Financial matters

The clerk had provided the bank reconciliation and respective bank statements up to 30 June 2017 prior to the meeting.

Councillors present were S Hayward(Chair), C Healey, I Williamson, T Longden, G StJohn Meyers and S Scott. 3 public. 65/1718 Mobile phones. The chair reminded everyone that these should be switched to silent mode.

66/1718 Co-option of new councillors. None. Two vacancies to be advertised in the newsletter.

67/1718 Apologies for absence C Fox.

68/1718 Confirmation of minutes. The minutes of the parish council meeting held on 12 July 2017 were signed as a true and complete record.

69/1718 Declarations of interest. None declared.

70/1718 Ongoing issues.

70.1 Bracken Hill. Notice to be erected on the gate. Property of Airmyn Parish Council, No Admittance. Weekly inspection of the site will be carried out. Resolved to make the gate secure and erect signage.

70.2 Bowls Club lease. This had been returned by the bowls club and now signed by the Chair for the coming year. A cheque had been received for the lease. The bowls club will attend to the leaning wall at the compost heap and the parish council will check re a new meter for electric specific for the Bowls Club.

70.3 Report from ERYC on the Taskforce walkabout. This comprehensive report had previously been circulated and there are no immediate safety concerns or matters which the parish council will have to deal with. The Environment Agency and Highways are to deal with matters appropriate to them. A newsletter item will ask residents to keep hedges and shrubs clear of footpaths and not to block the view of cyclists or motorists.

70.4 ERYC Highways will attend to issues raised by the village taskforce walkabout in the coming months and a schedule of work has been sent to the Clerk.

70.5 Pigs on riverbank. A newsletter from the Environment agency requests that the grass seed and young grass are left undisturbed on the foreshore. It is hoped that residents adhere to this request. It has been noted that a boat is being stored on owner's land near the Environment agency work. A fence has been attached to the flood defence wall. Riparian rights cannot impede the work of the Environment Agency. An invitation is to be issued to Mr P Desmond of the Environment agency to discuss the bastions placed in the village. The PCSO will be contacted re any issues of concern Which are the ERYC and Environment agency responsibility.

72.3 Overgrown hedging out of the 30mph boundary. Noted but can only be cut back safely at the bottom which has been carried out. Further work will have to be carried out on the higher parts of the hedge.

72.4 Dogs in the play area. The Clerk had obtained new stickers which can be given out to anyone allowing dog fouling in the play area and can also be included in the play area signage.

72.5 Allotments. The newsletter will be asked to carry an article on whether any resident would like an allotment.

72.7 Defibrillator at the hall. Carried forward to the next agenda.
