#### AIRMYN PARISH COUNCIL

Minutes of a meeting of Airmyn Parish Council held on Wednesday, 8 April 2015 in Airmyn Memorial Hall at 7.45pm.

Present: Councillors Spence (Chairman), Cowling, Dickinson, Lester, Pickering, Watson, the Clerk, Cllr Fox of the East Riding of Yorkshire Council and four members of the public.

Apologies: Apologies for absence were received from Councillor Peake.

1/1516 Mobile phones

The Chairman reminded members that mobiles should be switched to silent mode.

2/1516 <u>Declarations of interest</u>

There were no declarations of interest in items on the agenda.

3/1516 Confirmation of the minutes

RESOLVED that this item is deferred to the end of the meeting to be discussed with members of the press excluded.

4/1516 Matters arising from the minutes

RESOLVED that this item is deferred to the end of the meeting to be discussed with members of the press excluded.

5/1516 Reports from the Airmyn Community Association

Councillor Cowling reported from recent meetings.

6/1516 Clocktower matters

The clerk reported that the new safety harness had been delivered to Cllr Crossland-Clark. It was further reported that Councillor Crossland-Clark was in the process of writing a method statement for the voluntary clock winders

The issue of automation of the winding mechanism was raised and the clerk sought advice on what needed to be done to progress this matter. She was advised that the council had agreed to write to two clock maintenance companies in Derby and Leeds with regard to the mechanism.

### 7/1516 Planning applications

Premier Inn

The council did not have a copy of an application for an internally illuminated free standing pole sign at the Premier Inn.

RESOLVED that the council delegate the decision on this application in conjunction with the opinions of Councillors Sweet and Crossland-Clark; which would enable the clerk to pass the council's views to the East Riding of Yorkshire Council in the timescale permitted.

Conditions applied to the planning permission for Elite Furnishings

Councillor Watson declared a Disclosable Pecuniary Interest in this matter and left the room.

The chairman read correspondence from ERYC Planning Department advising that as one of

the conditions of the application is that mature specimen trees are planted around the site, this would be monitored by the planning authority. Members expressed concern that there is insufficient space for this to happen.

RESOLVED to write to Anthony Devey at ERYC to ask him to provide a written assurance that there is adequate space around the entire perimeter of the site for mature specimens to be planted and to grow to their full potential.

#### 8/1516 Financial Matters

It was noted that an allowance of £15 per month to contribute towards home working expenses had been agreed by the council as policy some time ago. The chairman confirmed that the clerk had been given a copy of this policy and that the clerk must claim the £15 on a monthly basis by separate cheque.

### 10/1516 Appointment of internal auditor

RESOLVED that Mr Andrew Bosmans is appointed as the council's internal auditor.

# 11/1516 Bracken Hill - The Conservation Volunteers

Councillor Cowling read a proposal drafted by the TCV for works to be done to Bracken Hill to bring the site up to a standard that it is fit for public use. The proposal was welcomed and councillor Cowling was thanked for the work that she had put in to this initiative. The proposal involves TCV making an application to the Two Ridings Community Foundation for up to £10,000 for improvement works to the ground, flora and fauna. Some members expressed concern that the parish council may be leaving itself open to claims if the surface of the land is unsuitable for public activities.

RESOLVED that Councillor Cowling and the Clerk continue to liaise with TCV and to particular check what kind of ground works are to be carried out.

RESOLVED that TCV are asked to provide written assurance that it will indemnify Airmyn Parish Council against any loss whilst the works are taking place.

North Airmyn Grange

The Chairman read a letter from a parishioner expressing concern about the number of HGVs being parked at North Airmyn Grange at any one time; he also expressed concern over the planning restriction on the height of the pallets being stored. Members discussed that the council had already checked the planning conditions for the maximum height of the pallets and had asked and had a response from the planning department on this matter. The council remained content that the planning condition was not being contravened. There was concern about the number of HGVs however.

RESOLVED that the clerk checks the conditions in the planning permission and conditions with regard to any limitations on the number of HGVs that can be parked at any one time and to report back to the council at its next meeting.

RESOLVED that the clerk write to the resident to explain what has been done, is being done and to thank him for his notification.

East Riding Plan Modifications

RESOLVED that if possible, Councillors Peake, Spence and Cowling would scrutinise the document for any modifications relating to Airmyn Parish, however it was felt that the opportunity to do this may have already passed.

The meeting noted that only one person had been nominated to stand as a councillor. The chairman took opportunity to explain to members of the public and council that the other 8 members were standing down either after a long period of service or for genuine reasons. She particularly praised Councillor Tony Watson who had been on the council for 30 years and had hardly missed a meeting in that time — his contribution to the parish and the council were noted and thanks were given.
