

MINUTES OF THE AIRMYN PARISH COUNCIL MEETING HELD ON THE 12
OCTOBER 2016 IN THE GEORGE DALES ROOM, AIRMYN MEMORIAL HALL, AT
7.00pm.

Councillors Present were Cllr J Peake(Chair), Cllr S Hayward, Cllr C Fox and Cllr P Gardner.

2 members of the public attended. The Chair of Emergency Committee, Mrs M Mason Pitt, also attended and updated the parish council the current position regarding the Environment agency work to be undertaken. An update to every home will be delivered soon. Flood wardens are required on a volunteer basis.94% of the village is registered with floodline. The school may be used for a flood exhibition due to the hall being used every day.
