Minutes of the Airmyn Parish Council meeting held on Wednesday 8 November 2017 at 7.00pm, in the George Dales Room, Airmyn Memorial Hall.

- 115/1718 Mobile phones. The chair reminded everyone that phones should be switched to silent mode.

- 118/1718 <u>Confirmation of minutes.</u> The minutes of the meeting held on 8 November 2017 had previously been circulated and were agreed as a true and complete record and signed accordingly.

- 120.1 Bracken Hill. Mrs J Peake presented the following information to the parish councillors. In 1920 Bracken Hill was taken on as a Council Tip and this closed in 1979. The parish council purchased half of the site from Humberside County Council who used the other half for the new amenity site and recycling centre. Humberside County Council capped the site with one metre of soil. The Parish council then leased it to the Woodland Trust for 25 years. The vision was that Bracken Hill would be an amenity for the community at the end of the 25-year lease.

Further discussion took place. The grant received from Two Ridings in 2016/2017 was well received but no volunteers have come forward to lead the ongoing work needed on this site. The parish council must make regular inspections, ensure Insurance requirements are met and that signage is correct and visible throughout the site. The parish councillors discussed the future of this site in view of recent issues raised by residents. The conclusion was that it is unreasonable, with currently only 4 parish councillors to maintain this site. The clerk was asked to contact ERYC for advice, querying a handback of this site and to discuss appropriate signage as they are equipped to manage the risks involved. Resolved for the clerk to issue a letter to the appropriate ERYC officer re the land at Bracken Hill.

120.2 Land Claim for Possessory Title.2 Pieces of land were given as an asset for the village. Quotes are to be sought from solicitors for the next meeting re claiming title on these two pieces of land. The parish council should act as custodians which was the original intention in gifting the land to the village.

120.3 Quotes for playground. The playground needs repairs and equipment replaced due to its age. Simply Playground have quoted £3605 and Playdales £3982.15. The decision will be made at the next meeting as to the work to be ordered. The clerk was asked to detail pieces which are repairs and itemise costs for new equipment for consideration by the councillors. The fencing costs are included in one quote but not the other. Local quotes may be obtained for fencing.
